Overview

In my philosophical work, I articulate a series of arguments in defense of dark sky, forest, and biodiversity conservation. I contribute to the environmental ethics literature in a distinctive way by critically evaluating research in the empirical sciences and environmental psychology, which altogether demonstrate that the loss of these environmental features constitutes a global threat to human psychophysiological health and more-than-human, ecological flourishing. I situate this practical approach within a broader ethical framework (inspired largely by Indian, ecofeminist, and indigenous philosophies), which conceives of our relationship with the more-than-human-world as descriptively and normatively *reciprocal* in nature. Utilizing these tools, I argue that e.g., we are ethically obligated to mitigate the global overabundance of artificial light at night and to resist the ubiquity of cross-modally replete simulations of biodiverse spaces.

My current work draws upon these general themes, interweaving them more explicitly with discussions pertaining to the eudaemonistic, relational values and virtues that we ought to cultivate through our interactions with the more-than-human world. Included in these discussions, I emphasize the import of cultivating a series of environmental, moral emotions, including (but not limited to): reverence, felt connectedness, awe, and wonder. I am also currently thinking about intelligence and sentience in forested ecosystems (individually and systemically), and whether these attributions specifically ground the expansion of our moral sphere to include e.g., plants and fungi under its purview.
